# CENTRE FOR CHRONIC DISEASE PREVENTION AND MANAGEMENT SEED GRANT PROGRAM FALL 2024 COMPETITION

## The purpose of Centre for Chronic Disease Prevention and Management (CCDPM) Seed Grant is to:

- Provide seed funding for <u>research activities</u> that will facilitate the preparation of operating grant applications in the near future.
- Build collaborations within and outside of our Centre.
- Foster success in external funding competitions

## **Funding**

- The fall 2024 competition will have \$60K to disburse with a maximum of \$20K/project
- Funds may be used for research consumables such as research staff/student salaries, participant remuneration, field research expenses (e.g., local travel)
- Funds may not be used to purchase new equipment or for conference travel
- Funds must be used within 2 years of release

### Eligibility

- Primary applicants must be a CCDPM Investigator, Affiliate Investigator, Affiliate Clinician, or Post-Doctoral Fellow who is a member in good standing as of September 1, 2024
  - Note that whilst post-doctoral fellows can apply as primary applicant the grant will be setup within the supervisor's laboratory
  - Graduate students are not eligible to apply as the primary applicant but may be co-applicants
- Investigators can only apply for one Seed Grant as the primary applicant per funding round and cannot hold more than one CCDPM Seed Grant as primary applicant at a time
- A maximum of two applications may be submitted from a single lab (e.g., one application from the Investigator and one from a post-doctoral fellow in the Investigator's lab) but these must address fundamentally different topics
- The project must align with the Centre's mission and research pillars Mission: Advance health through discovery and translation

The CCDPM focuses on three primary research pillars, with prevention and self-management as the crosscutting themes:

- (1) diabetes and obesity;
- (2) cardiovascular health;
- (3) neurological disorders.

#### **Application Evaluation Criteria**

- Applications will be evaluated based on the following:
  - o The strength, appropriateness and feasibility of the research plan
  - o The significance, impact, and originality of the work
  - The potential for the research to have an impact on clinical practice/outcomes
  - The potential for the research to build toward a Tricouncil or major foundation grant application (e.g., Heart and Stroke)

- The suitability of the research environment including availability of equipment, personnel and community partners (where appropriate) to complete the proposed project
- o The alignment of the proposal with the CCDPM's mission and research pillars
- Priority will be given to applicants who will use the data to formulate an application for their first operating grant, followed by established applicants who are working together on a new area/project/line of research.
- The adjudication committee will be chaired by the Centre Director and will be comprised of scientists and at least one clinician, including previous seed grant recipients.

#### **Conditions of the Award**

- An RPIF will be required for **successful** applications.
- All grants are for a two-year period.
- The project must start within 6 months of the notice of award. If the project is not started within this period, the funds may be reverted back to the CCDPM and may be awarded to other applicants.
- A final report is due no later than 26 months after the award date.
  - o Report templates will be provided
  - Award recipients must report annually on grant applications and funding received as a result of CCDPM Seed Grant support
- Award recipients are expected to assist in the adjudication of applications in the next competition cycle.
- Award recipients are expected to participate in, and present their findings at the SMP/CCDPM annual research conference.
- Award recipients must acknowledge funding support from the Centre for Chronic Disease Prevention and Management on any publications or presentations resulting from the award.

Provide budget estimates for the research project. Each budget item should be supported by a short justification statement and include applicable taxes. Maximum 1 page (5000 characters).
